Terms & Conditions

1. The UK Games Fund Awards (the “Awards”) recognise high performance by the teams and companies that UKGTF funds and supports and is open to all companies funded by the UK Games Fund and participants in Tranzfuser. The Awards are not open to employees or agencies of UK Games Talent and Finance CIC (“UKGTF”) or DC Thomson (“DCT”) together the Awards Promoters, group companies or family members of the Awards Promoters, or anyone else connected with the creation or administration of the Awards, with the exception of the Local Hub Award. All entrants must have a registered office in the UK or have a place of business in the UK.
2. Entrants to the Awards shall be deemed to have accepted these terms and conditions. For more information about the awards, please see [here](#).
3. To enter, please follow the instructions online. Entry opens at 09:00 on the 12th July and the deadline for entries to all categories is at 17:00 on 8th August 2018. Entries received outside this time period will not be processed. UKGTF reserves the right in its absolute discretion to extend the closing date where the entries received are of insufficient quality. 4. You are responsible for the cost (if any) of preparing and sending your Awards entry to us.
5. No responsibility is taken for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of submission of the entry is not proof of receipt. UKGTF reserves the right to not process entries which are illegible or those that do not include the correct amount of entered material.
6. Entries must be the original work of those submitting the application. Joint submissions will not be accepted in any category. Prior consent must be sought from any individual or company put forward in any of the individual categories.
7. By submitting an application form to enter the Awards, you confirm that you have the right to enter and have obtained all and any consents, permissions and authorisations that may be necessary in order for you to enter. UKGTF reserve the right to disqualify any entrant for the following reasons, an entrant: does not comply with these terms and conditions; has not obtained the consents detailed above; is not eligible to enter the Awards; or cannot be contacted. In the event of disqualification, UKGTF may select a new shortlist entrant and/or winners in accordance with these terms and conditions.

Judging the Awards

8. The criteria to be applied by the judges are set out in the 'categories' section here. The judges will select the shortlisted entrants from all valid entries received in each category. The judging panel includes at least 2 members that are independent of the Awards Promoters.

9. Only shortlisted entrants will be contacted by UKGTF and no other feedback will be given or correspondence entered into by the Awards Promoters.

10. Shortlisted entrants will be contacted by email (on the address provided in the application) after the judging week commencing 1st October 2018. If a shortlisted entrant does not respond to UKGTF within 14 days of being notified, their place on the shortlist will be forfeited and UKGTF shall be entitled to select another entrant in accordance with the process described above. Two representatives from all nominees will be invited to attend the Showcase and Awards ceremony to take place over two days in November 2018 in Dundee and UKGTF will make a contribution to the travel and subsistence costs of the nominees. The winners in each category of the Awards, as chosen by the judges, will be announced at the Awards ceremony. More complete details of the Awards ceremony will be provided to shortlisted entrants at the time UKGTF notifies them that they have been included as a nominee for a particular category.

11. The judges' decision is final and no negotiations or correspondence with entrants will be entered into. Entrants must not contact, or try to contact, the judges in any way in connection with Awards or in any way try to influence the decision of the judges.

12. UKGTF accepts no responsibility for any costs associated with submitting entries. For the avoidance of doubt, there are no other prizes awarded to the winners, runners-ups or shortlisted entrants.

The Prizes

13. The winners will receive an invitation to the awards ceremony, a trophy. UKGTF accepts no responsibility for any costs associated with the prize that are not expressly included in the prize. Should a winner be unable to attend the awards ceremony, they will still win the prize. In the event a winner declines the prize, another winner will be selected by the judges using the same criteria set out at paragraph 8 and here.

14. The winners will be notified at the Awards ceremony on or after 14th November 2018 and given details of how to receive their Award.

15. The name of the Nominees will be published prior to the Awards event and the names of the winners, will be published after the Awards event.

16. The prizes are non-exchangeable, non-transferable and not redeemable for cash or any other prize.

Other Terms & Conditions

17. Nominees and Winners may be required to take part in promotional activity related to the Awards and the winners shall participate in such activity on the Awards Promoters' reasonable request. Each entrant consents to the use by the Awards Promoters' and its related companies and all Sponsors, both before and after the closing date of the Awards for an unlimited time, of the winner's voice, image, photograph and name for publicity purposes (in any medium, including still photographs and films, and on the internet, including any websites hosted by the Awards Promoters' related companies and Sponsors) and in advertising, marketing or promotional material without additional compensation or prior notice and, in entering the Awards, all entrants consent to the same.

18. The Awards Promoters accept no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Awards. The Awards Promoters further disclaims liability for any injury or damage to your or any other person computer relating to or resulting from participation in or downloading any materials in connection with the Awards.

19. Nothing shall exclude the liability of Awards Promoters for death, fraud or personal injury as a result of its negligence.

20. The Awards Promoters shall be under no obligation to publish or exhibit any entry.

21. In consideration of the Awards Promoters and Sponsors ("Organisers") agreeing to consider an entry, each entrant:

(a) grants the organiser a royalty-free licence to copy, edit, display, publish, broadcast and make available their entry in any format in connection with the Awards or promotion of the Awards including Permission for your entry to be published on Organisers' websites including but not limited to Organisers' Websites and on any social media account controlled by the Organisers, including but not limited to Organisers' Social Media Accounts, and you grant the Organisers a non-exclusive, royalty-free, worldwide licence to use and publish information about your entry in electronic format (including on Organisers' Websites and Social Media Accounts) and hard copy including in the Organisers' publications for purposes connected with the Awards, and to adapt the entry to enable such publication (including to crop or otherwise edit it for such purposes), and you hereby irrevocably waive, for the benefit of the Organisers, all moral rights in the entry to which you are entitled;

(b) agrees that the Organisers may publish their name and/or their organisation's name in connection with Organisers' use of the entry;

(c) warrants that the work submitted with their entry is their own or the relevant team original work, that it is not defamatory and that it shall not infringe any third-party rights including, without limitation, privacy; and

(d) agrees that the Organisers' may grant to its partners and/or associated companies a sub-licence of the rights licensed to the Organisers under these terms and conditions on such terms as the Organisers shall agree in its sole discretion.

22. The Awards Promoters reserve the right at any time and from time to time to modify or discontinue, temporarily or permanently, the Awards or any feature thereof with or without prior notice due to reasons outside its control (including, without limitation, in the case of anticipated, suspected, or actual fraud). The decision of the Awards Promoters in all matters relating to the Awards is final and no correspondence will be entered into. The Awards Promoters shall not be liable for any failure to comply with its obligations relating to the Awards where the failure is caused by something outside its reasonable control. Such circumstances shall include, but not be limited to, weather conditions, fire, flood, hurricane, strike, industrial dispute, war, hostilities, political unrest, riots, civil commotion, inevitable accidents, supervening legislation or any other circumstances amounting to force majeure.

23. The Awards and these terms and conditions shall be governed by English law and entrants to the Awards submit to the exclusive jurisdiction of the English courts.

24. UKGTF shall use and take care of any personal information you supply to it as described in its privacy policy, a copy of which can be seen at <https://ukgamesfund.com/about/privacy-policy/>, and in accordance with data protection legislation. By entering the Awards, you consent to the collection, retention, usage and distribution of your personal information in order to process and contact you about your Awards entry, and for the purposes outlined in paragraphs 15, 17 and 21 above all in accordance with our Privacy Policy.
