





- Further consolidation likely
- Energy transition infra is emerging market
- Seen as lowest ESG risk within sector
- Long term investment horizons challenged by future FID risk
- Capital gap emerging in early stage transition projects


Oilfield Services

- Opportunity rich for those with conviction


Active Upstream M&A in 2021

OFS Market Cap 2014 vs 2021






